Here's your chance to share your quilt with the people of Denver! A juried exhibit of approximately 40 quilts made by CQC members will be displayed at the Mancuso Brothers Show, Denver National Quilt Festival, from May 1-4, 2008. Let's show the people of Colorado what CQC members can do!!!

Quilts will be juried by the CQC quilt show committee. The bottom half of the entry form and a photo of the quilt need to be mailed to Joan FitzSimons by March 30. (A digital photo may be emailed to her at: jdfitzsimons@comcast.net). Acceptance letters will be mailed by April 9, and those quilts selected for the exhibit need to be delivered to Joan FitzSimons in person or mailed to her home (1442 S. Vaughn Circle, Aurora, CO 80012 303-751-3880) to arrive by April 21. Participants (or a designated person) need to pick up quilts from Joan by May 15, or, if \$18.50 postage is included with the entry form, it will be mailed back to the entrant. (If you wish to have your quilt insured, check with the post office to get the insurance amount and include that amount in your check plus the \$18.50.) **Quilts can also be picked up at the CQC meeting on May 17 in Golden.** Please be sure that your quilt has a 4" sleeve on the top of the back side and put your quilt into a cloth bag or pillowcase. Make sure your quilt has a label with your name on it. Also please put your name on the cloth bag. **Quilts in plastic bags will not be accepted!**
